

Annual General Meeting Minutes

May 27th 2018

The annual general congregational meeting of Lakeview United Church was held at the Church on Sunday, May 27, 2018, following morning worship.

1. CALL TO ORDER

Hank Klassen called the meeting to order at 11:00 am.

2. OPENING PRAYER AND MINUTE OF SILENCE

An Opening Prayer was offered by Minister Emeritus, Gerry Scharff. An In Memorium was offered for Laura Jean (Midge) Gilschrist, Doreen Newby, and Eleanor McCann who died in this past year.

3. MOTION FOR APPOINTMENT OF CHAIR AND SECRETARY

Motion to appoint Hank Klassen chair for this AGM was made by Ron Gillean, seconded by Daryl Sedor. Carried.

Motion to appoint Peter Prest secretary for this AGM was made by Craig Cheffins and seconded by Fiona Hayes. Carried.

4. MOTION TO APPROVE AGENDA

Motion to approve the agenda was made by Barb Spence and seconded by Louise Poudrette. Carried.

Note: In Rev. Jope Langejan's absence, we will substitute Gerry Scharff's name where it appears in the agenda.

5. ADHERENTS AND QUORUM CONFIRMATION

Hank Klassen explained that by United Church requirements, adherents who contribute regularly to the support of the congregation will be granted voting privileges at this AGM. He also informed the meeting that the necessary quorum to hold this meeting was present. Voting would be show of hands.

6. MOTION FOR APPROVAL OF AGM MINUTES OF MAY 28, 2017

Moved BY Doug Jamieson and seconded by Fiona Hayes that we accept the minutes of the 2017 as printed. Carried.

7. APPROVE ANNUAL REPORT AS CHANGED

Daryl Sedor asked that a change on page 18 be made from "The total from folks donating over \$600.00" to "over \$800.00".

Louise Poudrette moved and Daryl Sedor seconded that the Annual Report as changed be accepted. Carried.

8. MOTION: HONORARIUM FOR TREASURER AND CHAIR OF COUNCIL

Motion to accept this slate of Council was made by Fiona Hayes and seconded by Daryl Sedor. Carried.

Motion that current Council be allowed to seek members to fill open positions was made by Fiona Hayes and seconded by Murray Rose. Carried.

10. RECOGNITION OF FAITHFUL SERVICE

Fiona Hayes requested a recognition of faithful service be given to those serving on the Council. AGM members provided a round of applause.

11. MOTION FROM THE FLOOR RE: COMBINING AGM AND ANNUAL FINANCE MEETING

Don Linton moved and Fiona Hayes seconded that a combined meeting of the AGM and AFM be held in the first quarter of the calendar year. Defeated.

An amendment was made by Nancy Rose, seconded by Julie Prest to table this motion until next year. Defeated.

Motion by Daryl Sedor, seconded by Heather Mayers that Council investigate the feasibility of the previous motion. Carried.

12. THANK YOU TO OUR STAFF

A thank you to our staff was proposed by Fiona Hayes. Accepted with applause.

Move to adjourn was made by Daryl Sedor. Meeting adjourned at 12:00 pm.

Finance & Facilities Committee Report

Finance

The Finance Committee is a Sub-Committee of the Facilities & Finance Committee that reports to the Church Council. The Treasurer and other members of this committee work with the Council to compile the annual budget, track spending and monitor LUC's investments.

For at least the last four years (at least), there has been no Chair of the Finance Committee, or of the Facilities & Finance Committee. The Treasurer has assumed this role in the interim, and it is of ongoing concern that there is no other level of formal financial oversight, and that the workload of this position falls onto the Treasurer position.

The Treasurer (Paige Martin) presented the 2018 Annual Financial Report and 2019 Budget to Lakeview United Church members and adherents on March 3, 2019.

The Investment Committee (Don Linton, Hank Klassen), is a sub-set of the Board of and Trustees. They continued to monitor the investments in GIC's and the Canoe Capital Fund (formerly Fiera).

Pledgefest this year was managed by Heather Mayers with support from Carolyn Bosch.

Ted Prince, Counter Coordinator, ensures that Sunday morning volunteers are available to count each weeks' givings and make deposits to the bank. He is always seeking additional volunteers.

Shelly Logan-Gordanier continues in the role of ADP Payroll Coordinator. She coordinated payment of our full time employees in compliance with the United Church of Canada, the provincial and federal government requirements.

Nancy Gillean, Office Liaison, continues to help our Office Administrator Arda Kristanto.

Many thanks to the above-mentioned volunteers (and staff) for filling and fulfilling these roles that keep Lakeview United Church in good and sound financial standing.

There are more than a few vacancies and some of these dedicated volunteers have served well beyond the expected length of a two year term. Please consider stepping up to fill any of the above-mentioned positions which are vital to ongoing financial viability of our church.

Property

The Facility committee has the primary responsibility in managing and reporting to council on:

• property management, rentals, repairs and improvements

The property management saw several repair and replacement projects this fiscal year:

Various pieces of sound and AV equipment were replaced or added to replace old equipment.

Some minor alterations were undertaken in order to allow the new Student Inc. before and after school program to obtain their occupancy permit. Previously a

"change of use was" approved through the Development Permit process with The City of Calgary.

The janitorial and exterior maintenance services continued to be provided under a 3 year service contract with Calgary Services Ltd.

In the spring of 2019 the pergola over the front walk was removed as it had deteriorated and was in danger of failing completely. There are no plans to replace this structure.

Paving repairs are being carried out in June 2019, which should extend the life of the paving by a few more years.

Rentals

Rental activity and use by various groups are making for a busy facility.

We have had some additions this year:

- 1. Student Inc. before and after school for Grade 4 and 5 students started renting in January 2018. Their program did not start up as planned and now is expected to start in early September and will be using 4 rooms along the hallway in the lower level of the Church.
- 2. Alanon and Alateen (affiliated with AA) are renting space weekly (Board Room and Group Room). They started recently in 2019.
- 3. Reiki Spiritual healing training started recently in 2019. Once a month on Saturday in Lower Hall. They have suspended sessions until January as the leader has an out of town contract.

Calgary Girls Choir has shown interest in renting from Lakeview. They would rent the Choir room and the adjacent room on a daily basis (Monday to Friday). They require Choir practice in Sanctuary three nights per week. At this time we can accommodate only two of their nights. Their rental is pending a decision from their Board of Directors. PossAbilities rental is in jeopardy currently as they are 3 months behind in their rent plus some other issues.

Minister's Report

I begin my Annual Report with a little bit of theological thought and please bear with me while I attempt to put my thoughts onto paper. In the biblical story of the feeding of the five thousand, we need to recognize that Jesus did not act alone and this becomes the key to his 'miracle'. He acted in concert with others and evoked the abundance of community. He brought folks together to put their faith into action so that they could feed each other with the scarcity they had and to make that scarcity into overflowing baskets. Ultimately, the body of Christ, so central to incarnational theology or in easier terms to understand, embodiment of the divine, is not the physical body of Jesus but the corporate body of those who gather around the Spirit, wherever it is found. Jesus exercises the only kind of leadership that can evoke authentic community – a leadership which risks failure by making space for other people to act. And when a leader is willing to trust the abundance that people have and can generate together, willing to take the risk of inviting people to share from the abundance, then and only then may true community emerge. I sense that our last annual year has had such moments and that what has been generated has truly been spirit-filled and not only empowering but more importantly, enriching.

As I look back upon the happenings of the last term a smile comes across my face. I realize that I can look into the mirror and ask, "Have I done what I have been called to do?" and I can answer succinctly, "Yes, I have." I have experienced countless moments of grace and have always worked towards a better understanding of who I am as a child of God and also as a leader in this community of faith and all of the other 'communities' which I either belong to or serve. I periodically go back to the Joint Needs Assessment of five years ago which was structured before I had arrived here at Lakeview United Church and always make sure that what your hopes and

dreams were at that time are being fulfilled through my ministry. Your voice is what counts and your visions are what I strive to make realities. In short, I am the employee and all of you are the employers. I am not 'the way and the truth and the life'...I will leave that to someone who truly is and who we worship. I am an instrument of the Living Christ and will remain so, always serving each of you in the best way that I can.

And now, with this being the Annual Report, I sense that it might be very helpful in sharing what has happened since July 1st of last year and what stands out as some of the things or moments of grace which may need recognition. I will put them into point form to make it easier but we all need to realize that one is no more important than the other:

- 1) Worship This category continues to be a most central part of not just my ministry but also of your 'religiosity'. Sunday services are a central part of our faith journey as we struggle with what the biblical text says to us, with what our daily newscast portray to us as the world we live in, and what we can do in the face of these challenges. It is through our worship where we experience the joy and the community and hopefully, uplifting and thought-provoking messages, prayers, and music.
- 2) <u>Children & Youth</u> This continues to be a struggle but we need to be people of faith and to be more invitational and creative in terms of surrounding our children and our youth with being 'caught' by church instead of 'taught' (and I borrow this openly from someone who has truly 'caught' the Spirit). I offer thanks, and deep thanks, to those who give up their opportunities of worshiping to lead our children and youth.
- 3) <u>Book Studies/Bible Studies</u> Wonderful attendance at all of these which are either spear-headed by myself or other very capable leaders of this faith community. I always marvel at the wisdom that each person has and the openness with which we allow ourselves to share in some of the toughest questions.
- 4) <u>Special Services</u> From Staywell to Garrison, Palm Sunday, Maundy Thursday, Good Friday, Easter 'sonrise' and Easter Sunday service,

Remembrance Sunday, the Advent and Christmas season services and Presbytery (at last years' time) to Chinook Winds Regional services, to just name a few, which keeps the message always in the forefront and offers opportunities for everyone to get involved with experiencing 'Spirit'.



- 5) <u>Baptisms, Weddings, Funerals</u> This is always a large part of my ministry and serves the community in a different sense. I offer my thanks to all of those who help with music, audio-visual, kitchen set-up and tear-down, and so on.
- 6) Other LUC related Events The after worship lunches, the suppers, the garage sale, looking after our refugee family, hosting clustering meetings, being friends and neighbours to our rental folks, hosting concerts for the community, sharing in affirming functions, hospital visitations, Entheos retreat, community events, and the list becomes somewhat endless in what we do in and around the community.

July 2018 – June 30, 2019 has been a wonderful journey together and I again am so humbled by all of the hopes and dreams, the prayers and actions, and love and compassion that has so freely come from the hearts of each and every one of you. I sense that your focus has always seemed to be to strive for greater things and to seek the heart of God in all that you do. And in looking at the bigger picture, these 5+ years have gone by quickly and may go down in the annals of the Pastoral Charges' history as 'times of change' and 'times of growth' and I personally feel so privileged to have been a wonderful part of it. The financial situations have been good, the numbers in the pews have been somewhat consistent, we have worked diligently to feed our children and youth in ways which nurture them, our building is in decent shape, and there is a general sense that the Spirit moves through all that is hoped and all that is accomplished. It is through believing in 'self' and believing in doing things together where 'church' becomes more than just a word – it becomes a community of 'selfs' where God's kingdom becomes realized...hats off to all of you for your stick-to-itiveness and your belief in each other!

I realize that this may be a small picture of who we are and what we have accomplished (or what I may have done) but I truly encourage you to look back at these deeds and to offer thank-yous to those who so diligently kept your church alive and your community alive. And to those whom I might have forgotten, accept my apologies and the blame would be on me. As I spend time on my sabbatical, I offer thanks to all of you for this opportunity of 'recharging my batteries' and of allowing me to grow deeper into the meaning of what ministry is all about as I visit many different denominations and see where the bigger picture is of God's realm.

Peace and blessings to all of you and may this upcoming year be one of wonder and one of newness. May the God of the ages touch your hearts and the Spirit of Christ live within you....shalom.


Faith Formation & Worship Report


From the letters we receive from the students and from Plan, it appears that our help is useful and much appreciated. They send their love and best wishes. On their behalf, thank you for your continued support.

Website Analytics Comparison 2018 – 2019

(SquareSpace legacy version 5 – version 7 upgrade)

lakeviewunitedchurch.com and lakeviewunitedchurch.ca



There has been a 16% increase in viewership from the legacy version 5 website to the new upgraded version 7 Lakeview United Church website which was launched September 30th, 2018. (Both were maintained daily in the time period examined.)

Most importantly there has been a 35% increase in page views by visitors during this period. It appears that page views are shifting from Church contact inquiries and rental fact finding to more specific searches relating to worship, what we stand for, and current church news and events. Currently we do not have a system in place to gauge whether this interest results in new Sunday attendees. Presently the website continues to be an underutilized Church tool.

Refugee Committee Report 2019

As most of you know, some members of Lakeview United Church decided to sponsor a refugee family from Syria in late 2015. These were: Raj Retnanandan (chair), Sue Spratt, Ron and Nancy Gillean, Bob and Peggy Gibennus (initially), Elizabeth Marshall, Jude Sampson, Rob and Diane Stinson, Don Linton, Paige Martin, Doug and Gwen Jamieson, Fiona Hayes, Barb Foster, Sherry Kovatz (initially), (and Lakeview friends Kerrie Hale and Irene Buckland). Funds for this came from donations, as well as a portion coming from the Planned Giving fund which has always been partially designed for "reaching out".

A couple of meetings were held in January 2016 with Raj in constant contact with the UCC Matching Centre in Ontario. We had about 2 days to pick our family from a group of several choices. We chose a young married couple with a child accompanied by a grandmother, a family of 4. When it became apparent that their arrival was imminent our preparations became urgent. An apartment and furnishings were found quickly with most articles donated. On Saturday February 13, 2016 our bewildered family arrived in their new apartment. Through an interpreter their first question was "How long will we be here?" They had been moved so many times in the past they believed they were arriving at another temporary establishment.

Our family was Ismail Alorfi, his wife Rola Bakar, and 8 month old little girl, Sham. Ismail's mother was to have accompanied them but she was detained for health reasons in Jordan, where the family had been living in a refugee camp. She was to arrive later.

With a great deal of assistance from the Lakeview members, our family settled into life in Calgary. We took them shopping; for government appointments; helped them apply for health cards, and SIN cards; made arrangements for immunizations; searched for a family doctor who spoke Arabic; took them to dental appointments; taught them how to use transit and obtain a bus pass; searched out and applied for ESL.

Rola was 3 months pregnant when she arrived. Subsequent ultrasound and prenatal tests were arranged. The family grew to 5 members within 2 years. A

second girl, Layan, was born November 2016; followed by a boy, Qasim, in 2017. Jude Samson had the surprise privilege of attending the birth of Qasim.

Ismail's mother ultimately decided to stay in Jordan. However it became apparent that Rola's mother and 3 siblings were seeking residency. Raj and Sue began the tedious process of applying to the government to sponsor them. Our applications were returned 3 times with minor issues; and as we were proceeding to reapply, the family was accepted (much to our surprise) in the UK. They are now residing in Leeds.

The Alorfis have outgrown their original apartment and have moved to Marlboro where they live among other Syrians. Ismail has full time seasonal work in construction/landscaping. In winter he receives EI, shovels snow, and attends classes in English. He has bought and sold at least 4 cars or trucks. He's a very responsible wage earner. We no longer need to support them.

We have \$6600 left of the money raised. On April 10 the committee met to decide how to proceed. It was felt that if more requests come in for more refugees another committee could be formed. Our work is done. \$1600 of the balance will be sent to the Rainbow Railroad, an organization which helps refugees of LGBTQ origin. The balance of \$5000 will be given to Matthew Berry who, with the help of CCIS, is seeking to bring over the family of a single mom residing in Lakeview. They are all from Kenya.

It has been a rewarding experience working with the Alorfis. They will be our life long friends. It was fun to be a part of the great Canadian effort to help refugees from Syria. Thanks to all who contributed and thanks be to God who guided us all the way.

Logo, banner and brochure

In the past year, the logo of LUC sailed through stormy seas. It was designed, modified and sought approval and finally came to shore as our official logo. The logo then floated up on to a 25-foot-long banner that flies proudly from the north side of the church. With these changes, a new brochure was needed proclaiming the values and services of our church. On initial run of 500 copies has been added to several times since.

More than 3 Wise Men (and Women)

Lakeview Fun Day

Lakeview Fun Day, June 8, 2019 was very successful. Avery, our Summer Student, had prepared materials for 80 flags. Towards the end of the event all the flags were

used and we used pieces of unhemmed cloth. The hardworking volunteers were kept busy with a steady stream of flag makers. As well as flag making, brochures about LUC and the United Church of Canada were available for the taking. Over 100 notices advertising Neighbour Day were distributed.

First Annual Neighbour Day, June 15, 2019

Neighbour Day was a huge success. We had prepared for 100 people and we had to make a quick run to IGA for more hot dogs and buns. Unofficial records suggest 163 hots dogs were consumed. The Butterfield Acres Mini Petting Zoo was the star attraction, delighting kids and adults. At one time, someone counted 25 children at the zoo. As well as children



we had a mixture of adults and seniors. The excellent contingent of LUC members served up hotdogs, drinks and chips as well as mingled with the crowd. Many LUC brochures were distributed and some conversations centred around church programs. Special guests included Jeromy Farkas, Councillor for Ward 11; Marshall Pope, Lakeview Community Association; and Leanne Crowchild from the T'suu Tina First Nation. People stayed well past the 12:00 shut down time.

Fishing in the Future

The RTF will continue to meet over the summer as we prepare to hire a Congregational Enhancement Coordinator. The CEC will provide three-year and five-year plans as to the direction of LUC. Promotion of programs and liaison with the community will be the focus of this position. This will begin Phase Two of the RTF mandate.

Plans are also underway for a Program Launch Day, to promote activities and programs that are operating in the church. Sunday, September 29 is the target date. The community will be invited to come and "Test Drive" our church. Committees will be asked to make a display of their activities or programs. Plan is on-going with balloons, snacks, and a World Wishing Well perhaps.

Board of Trustees Report

The Board of Trustees is mandated by the United Church of Canada to hold in trust the building and property. To this end the Board insures the building is adequately insured, well maintained, rental agreements are such as to protect the property and that any investments are sound.

The insurance coverage for the building remains at \$2,884,248. The trustees reviewed our insurance and received a quote from HUB International (who is group insurer for the United Church of Canada). For 2019 the premiums are \$4610.00, the same as 2018 and 2017.

Maintenance of the church is being kept up according to the Church Council plans. Likewise the rental terms of reference established several years ago are working well.

In 2016 the Lakeview Church Council reviewed and changed the church's investment policy. In May of 2016 \$312,000 of the church's bequests was invested with Fiera Capital Fund. This fund is the investment choice of the United Church of Canada. The earnings on this fund are doing well and some GIC money was moved to this fund on their maturity in May of 2017. The fund continues to perform well.

Changes were made in 2018 to the trustees on the title of deed. All the current trustees are now on the title and former trustees have been removed.

Al MacDonald resigned this year and I would like to thank him for his many years of service to this board. His sound council during that was greatly appreciated.

Thank you to George Zvanchuk, Paige Martin, Nancy Gillian, Don Linton, Diane Johnstone, Elizabeth Marshall, and Al MacDonald. Thank you also Rev. Jope Langejans for his advice.
